4. Consenting Agenda:

5. Unfinished/Old Business:

a. 6th Street Improvements – BG Consultants

We are still waiting on Evergy to relocate Utilities. Brian Foster asked City Council for approval to advertise the bid. Council approved sending this item out to bid.

b. Jackson Street Sewer – BG Consultants

Brian Foster stated that bids were higher than expected. Brian will email information on the bids.

c. City Hall Building - Update

Brain Foster went over the concept plan that had been put together after a meeting with Mayor Tim Pralle and employees with the City. This plan included ideas and thoughts for a new building. The plan was to give City Council things to consider and options to think about. Mayor Tim Pralle and Brian will evaluate some possibilities on a location. Mayor Pralle let Council know that the City Clerk is working with our Financial Advisors to see our options and what we can afford.

d. Parking at the Park Review

Mayor Tim Pralle state the property is cleaner but still needs to be worked on, its not where it needs to be. The homeowner for 107 N Lincoln agrees and she is diligently working on this. She is taking all the steps to better serve that area. Matt Ruhnke asked about the price that it would cost to cut the curb. Mayor Pralle said it should be under \$2500. The homeowner would like to keep parking how it is but if the City wants the fence put in she would ask for curb cutting cost. After discussion among Council a motion was made.

Matt Ruhnke made a motion for the City to finance the curb cut at 107 n Lincoln up to \$2350.00 and the resident will be responsible for rock to park on at the residence.
