#### 1. Water Tower - Cleaning

Mayor Tim Pralle went over prices for cleaning.

The two cheapest came in with Viking at \$1400.00 and Maguire at \$1650.00. The difference with the two is Viking dives where Maguire empty's the tank to clean.

Liquid Engineering came in at \$3000.00, Inland Potable came in at \$1600.00 if there is another tower in the area that they can do at the same time otherwise it would be \$2875.00, and Cunningham was at \$1850.00

Ben Wheeler the City Operator suggested to City Council to go with Viking. Ben explained the differences with diving and flushing the tower.

Debby Werth made a motion to go with Viking.

#### 2. Parking at the Park

A rock drive was quoted at \$6587.00 and 4" Concrete Paving was quoted at 26,399.50.

Treated privacy fence was quoted at \$2,400.00 for a  $3^{rd}$  party contractor to put it in place and \$1091.58 for the city crew to perform the work (based on time and average wages of 3 people).

Matt Ruhnke made a motion to go with a rock drive at \$6587.00, and the fence to be done by city workers at \$1098.58.
