

## **ORDINANCE NO. 2018-11**

**AN ORDINANCE REGULATING TRAFFIC WITHIN THE CORPORATE LIMITS OF THE CITY OF ST. GEORGE, KANSAS, BY CONTROLLING CERTAIN INTERSECTIONS AND AUTHORIZING THE PLACEMENT OF SIGNS.**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ST. GEORGE, KANSAS:**

**Section 1.** All persons operating motor vehicles on Dalton Gulch Road shall be controlled by a stop sign at the intersection with Chapman Road. A stop sign shall be erected on Dalton Gulch Road indicating the same.

**Section 2.** All persons operating motor vehicles on Prairie Meadow Road, both directions, shall be controlled by a stop sign at the intersection with Dalton Gulch Street. Stop signs shall be erected on Prairie Meadow Road indicating the same.

**Section 3.** All persons operating motor vehicles on Kelly Lane shall be controlled by a stop sign at the intersection with Prairie Meadow Road. A stop sign shall be erected on Kelly Lane indicating the same.

**Section 4.** All persons operating motor vehicles on Allen Lane shall be controlled by a stop sign at the intersection with Kelly Lane. A stop sign shall be erected on Allen Lane indicating the same.

**Section 5.** All persons operating motor vehicles on Allen Lane shall be controlled by a stop sign at the intersection with Prairie Meadow Road. A stop sign shall be erected on Allen Lane indicating the same.

**Section 6.** All persons operating motor vehicles on Trey Place shall be controlled by a stop sign at the intersection with Prairie Meadow Road. Stop signs shall be erected on Trey Place indicating the same.

**Section 7.** All persons operating motor vehicles on Heather Court shall be controlled by a stop sign at the intersection with Prairie Meadow Road. A stop sign shall be erected on Heather Court indicating the same.

**Section 8.** All persons operating motor vehicles on Lockett Lane shall be controlled by a stop sign at the northernmost intersection of Lockett Lane and Snyder Drive. A stop sign shall be erected on Lockett Lane indicating the same.

**Section 9.** All persons operating motor vehicles on Spani Drive shall be controlled by a stop sign at the intersection with Lockett Lane. A stop sign shall be erected on Spani Drive indicating the same.

**Section 10.** All persons operating motor vehicles on Snyder Drive shall be controlled by stop signs at the southernmost intersection of Lockett Lane and Snyder Drive. Stop signs shall be erected on Snyder Drive indicating the same.

**Section 11.** All persons operating motor vehicles on Snyder Circle shall be controlled by a stop sign at the intersection with Snyder Drive. A stop sign shall be erected on Snyder Circle indicating the same.

**Section 12.** All persons operating motor vehicles traveling on Quail Court shall be controlled by a stop sign at the intersection with Turkey Ridge Drive. A stop sign shall be erected on Quail Court indicating the same.

**Section 13.** The City is authorized to erect stop signs controlling the traffic as set forth in this ordinance.


**Section 14.** This ordinance shall take effect and be in force from and after its publication in the official city newspaper.
