

ORDINANCE NO. 2018-8

AN ORDINANCE LEVYING AND ASSESSING SPECIAL ASSESSMENTS ON CERTAIN LOTS, PIECES AND PARCELS OF LAND LIABLE FOR SUCH SPECIAL ASSESSMENTS TO PAY THE COSTS OF CERTAIN STREET IMPROVEMENTS IN RIVERVIEW HILLS, UNIT THREE, AN ADDITION TO THE CITY OF ST. GEORGE, POTTAWATOMIE COUNTY, KANSAS, AS AUTHORIZED BY AMENDED RESOLUTION 2015-03 OF THE CITY; AND PROVIDING FOR THE COLLECTION OF SUCH SPECIAL ASSESSMENTS.

WHEREAS, the governing body of the City of St. George, Kansas (the “City”), has authorized construction of certain Street improvements in Riverview Hills, Unit Three, an Addition to the City of St. George, Kansas, as hereinafter described (the “Street Improvements”), all as provided in Resolution No. 2015-03 of the City dated July 30, 2015 and as amended by Resolution No. 2016-01 dated February 4, 2016 (collectively, Resolution No. 2015-03 as amended by Resolution No. 2016-01, the “Amended Resolution No. 2015-03”); and

WHEREAS, the construction of the Street Improvements is complete and finished, and a hearing pursuant to K.S.A. 12-6a09 was held by the City’s governing body on August 6, 2018, at which time the assessments for the Street Improvements hereinafter described were set, approved and authorized to be levied upon Lots 66, 67, 68, 69, 79, 80, 81, 82, 83, 84, 85, 86, 87, 88, 89, 90, 91, 92, 93, 94 and 95, Riverview Hills, Unit Three, an addition to the City of St. George, Pottawatomie County, Kansas (the “Street Improvement District”), all as provided by K.S.A. 12-6a01 *et seq.*, as amended.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY THE CITY OF ST. GEORGE, KANSAS:

Section 1. The total costs of the Street Improvements authorized in the City’s Amended Resolution No. 2015-03 and described below is \$437,226.30:

The general nature of the Street Improvements is:

- (1) The construction of a 27-foot wide (back of curb to back of curb) to certain portions of Prairie Meadow Road and Heather Court lying within and fronting on the lots within the Proposed Street Improvement District street pavement and eyebrow pavement (5-inch asphalt on 4-inch base rock) with concrete curb and gutter, including excavation, embankment, compaction and utility sleeve installations;
- (2) the patching of Chapman Road for a storm sewer crossing with 6-inch asphalt pavement;
- (3) the installation of storm sewers, inlets and manholes including trenching, bedding, backfill, restoration, erosion control and incidental construction to make a complete project;
- (4) the engineering design, inspection, administration and interest on temporary notes issued to pay the costs of such street improvements; and,
- (5) all things necessary and incidental thereto,

all to provide for the construction of certain street improvements to be made to certain portions of Prairie Meadow Road and Heather Court, lying within the Street Improvement District described herein (the “Street Improvements”).

Section 2. The method of assessing the costs of the Street Improvements to and upon the benefited property in the Street Improvement District is to spread and assess the total costs for the Street Improvements among and equally upon and to each lot in the Street Improvement District with one hundred percent (100%) of such costs to be paid by the benefited property in the Street Improvement District.

Section 3. Special assessments to pay the costs of the Street Improvements are levied and assessed against upon Lots 66, 67, 68, 69, 79, 80, 81, 82, 83, 84, 85, 86, 87, 88, 89, 90, 91, 92, 93, 94 and 95, Riverview Hills, Unit Three, in the Street Improvement District and in the amounts set forth on **Exhibit A**, attached hereto, following the description of each lot.

Section 4. The amounts so levied and assessed shall be due and payable from and after the date of publication of this Ordinance No. 2018-8 (the "Ordinance"), and the City Clerk (a) shall notify the owners of the properties identified in said **Exhibit A** of the amounts of their respective assessments; (b) inform the owners that unless their respective assessments are paid within thirty (30) days from the date of the publication of this Ordinance in the official newspaper of the City, general obligation bonds will be issued therefor by the City. Such assessments shall be levied concurrently with general taxes and be payable in twenty (20) annual installments with the first such levy to begin in November, 2018.

Section 5. The City Clerk shall levy in the same manner and at the same time as other taxes are certified and levied for a period of twenty (20) years all of the assessments which have not been paid to the City within thirty (30) days after the publication of this Ordinance, together with interest on such unpaid amount thereof at a rate not exceeding the maximum rate as prescribed by the laws of the State of Kansas; and such unpaid amounts shall be placed on the tax rolls and collected as other taxes are collected, the levy for each year being a portion of the principal amount of the assessment plus one (1) year's interest on the amount remaining unpaid.

Section 6. This Ordinance shall take effect and be in force from and after its publication once in the official newspaper of the City.


