A RESOLUTION FIXING A TIME AND PLACE FOR A HEARING TO BE HELD BEFORE THE GOVERNING BODY OF THE CITY OF ST. GEORGE, KANSAS, WHEREIN THE OWNER, HIS OR HER AGENT, LIENHOLDERS OF RECORD, OCCUPANTS, AND OTHER PARTIES IN INTEREST OF CERTAIN PROPERTY MAY APPEAR AND SHOW CAUSE WHY SUCH STRUCTURES SHOULD NOT BE CONDEMNED AND ORDERED REPAIRED OR DEMOLISHED AS UNSAFE OR DANGEROUS STRUCTURES AS PROVIDED IN SECTION 108.1.1 UNSAFE STRUCTURES, SECTION 108.1.3 STRUCTURE UNFIT FOR HUMAN OCCUPANCY, AND SECTION 108.1.5 DANGEROUS STRUCTURE ON PREMISES

Judd McCormack made a motion to adopt Resolution 2023-01. Matt Ruhnke seconded the motion. Motion carried with 5 Ayes 0 Nays

a. Resolution 2023-02 Fee List

A RESOLUTION ESTABLISHING FEES FOR CERTAIN SERVICES, PERMITS, LICENSES AND OTHER ITEMS FOR THE CITY OF ST. GEORGE, KANSAS.

Mayor Tim Pralle expressed his concerns with the force mow portion on the fee list. After talking with the force mow company, it was brought to his attention that the property clean up and brush mowing is costing more than what is being charged. With that being said Mayor Pralle thought that we should have to fee amounts, \$150 per man hour for force mow with a 1 hour minimum and \$200 cleanup/brush mow per man hour with a 1 hour minimum. Council agreed. Debby Werth made a motion to adopt Resolution 2023-02 Fee List with the change of Force Mows to be \$150.00 per man hour with a 1 hour minimum, and cleanup/brush mow at \$200.00 per man hour with a 1 hour minimum. Matt Ruhnke seconded the motion.
