# 4. CONSENTING AGENDA:

**b.** City Council:

Debby Werth- Safe routes to school have been in contact and we are working on setting up a meeting to go over final items.

Judd McCormack- we have the possibility option of purchasing the house at 218 First St. The house and the lot 100x100. Judd explained to City Council the amounts that we are spending in renting between current city hall and the storage unit, he also explained how he visioned the future lot to look like as city hall. We have looked at different rates for a 5, 10, 15 lease purchase. A couple of us on the building commission had gone to look at this at the end of last week, to see if it would even be a workable solution and we think it is. Discussion was held about where the city shop would go, if we were to purchase the property. The council decided that they would all like to look at this before they make a decision. A special meeting was set for August 17 at 6pm for a decision on the property purchase.

e. Planning and Zoning Committee Reports:

Cody Liming informed the council that Kyle with Oneth Panning will be stepping down, he received a promotion at work and is unable to find the time to still be able to effectively be able to help us. Cody says that he will also be stepping down from planning and zoning in September/October of this year as his term has ended. Planning and zoning are currently working on strategic downtown planning.

- **j.** Saint George Community Enrichment Team:

Cody Liming asked city council for up to \$1000.00 of city funds for the fee for the generator and for a stage. Last year the City paid for the generator.

Matt Ruhnke made a motion to approve up to \$1,000 of city funds for the generator fee and a stage for Kawnsas Fest. Jeremy Holliday seconded the motion.

Motion carried with 5 Ayes 0 Nays.

Judd McCormack said we might have an issue getting the stage and food trucks where they are planning to have them. The Rogers are planning to put up a fence in the area that they let us use last year. A couple of committee members are going to talk with them to see if they will allow this again this year, but we might need to have another option.

## 8. OPEN COMMENTS:

Hans Tessman wanted to inform the council that a resident had passed and that The Ridge will be abating the property they will just need a little time. Dale Burton explained that Mr Tessman has reached out to code enforcement and that it has been noted and we understand due to the circumstances that more time will need to be given.

Andrew Donavan addressed the council with a couple of items. The first one being the nitrate issue at wells 7 and 8. Mr Donavan has been doing research and found a grant through the EPA. Mayor Pralle asked Mr Donavan to send the information to the City Clerk and we will take a look at it. We can always use help and appreciate that. Donavan second item was a code letter that he received about the easement behind his home. Dale Burton explained that this was not a violation letter, it was a reminder that they are responsible to the center of the street. Mr Donavan understood this but is asking that the city help, due to the incline and power poles. Mayor Pralle was going to look into this more.
