# A RESOLUTION PROVIDING FOR THE ADOPTION OF A TAX-ADVANTAGED FINANCING COMPLIANCE PROCEDURE RELATING TO OBLIGATIONS ISSUED AND TO BE ISSUED BY THE CITY OF ST. GEORGE, KANSAS.

**WHEREAS**, the City of St. George, Kansas (the "Issuer") is a political subdivision, duly created, organized and existing under the Constitution and laws of the State of Kansas (the "State"); and

**WHEREAS**, the Issuer is authorized, pursuant to the Constitution and statutes of State to issue bonds, notes, leases, certificates and other instruments that evidence indebtedness (collectively, the "Obligations") to finance certain improvements, projects and programs of the Issuer (collectively, the "Project Facilities"); and

**WHEREAS**, the Issuer anticipates future issuance of Obligations, the interest on which is intended to be excluded from gross income for federal income tax purposes or which is subsidized by the federal government (the "Tax-Advantaged Obligations"); and

**WHEREAS**, the Internal Revenue Code of 1986, as amended and regulations promulgated thereunder (collectively, the "Code"), impose ongoing requirements related to the investment, use and expenditure of proceeds of Tax-Advantaged Obligations and related funds and restrictions on use of the Project Facilities of the Issuer financed by such Tax-Advantaged Obligations; and

**WHEREAS**, the Issuer is committed to full compliance with all such requirements with respect to the Issuer's Tax-Advantaged Obligations.

## THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE CITY OF ST. GEORGE, KANSAS:

**Section 1. Compliance Procedure.** In order to comply with the requirements of the Code and directives of the Internal Revenue Service and to improve tax compliance and documentation, the governing body of the Issuer hereby adopts the Tax-Advantaged Financing Compliance Procedure, dated as September 9, 2021 (the "Compliance Procedure"), attached hereto as *Exhibit A*.

**Section 2. Permanent Record.** A copy of the Compliance Procedure shall be placed in the permanent records of the Issuer and shall be available for public inspection during regular business hours of the Issuer.

**Section 3. Effective Date.** This Resolution shall take effect and be in full force from and after its adoption by the governing body of the Issuer.

On September 9, 2021, the governing body of the City of St. George, Kansas passed an ordinance entitled:

AN ORDINANCE AUTHORIZING AND PROVIDING FOR THE ISSUANCE OF GENERAL OBLIGATION BONDS, SERIES 2021-A, OF THE CITY OF ST. GEORGE, KANSAS; PROVIDING FOR THE LEVY AND COLLECTION OF AN ANNUAL TAX FOR THE PURPOSE OF PAYING THE PRINCIPAL OF AND INTEREST ON SAID BONDS AS THEY BECOME DUE; AUTHORIZING CERTAIN OTHER DOCUMENTS AND ACTIONS IN CONNECTION THEREWITH; AND MAKING CERTAIN COVENANTS WITH RESPECT THERETO.

The Series 2021-A Bonds approved by the Ordinance are being issued in the principal amount set forth therein to finance certain street improvements in the City and refund previously issued general obligation bonds of the City, and constitute general obligations of the City payable as to both principal and interest, to the extent necessary, from ad valorem taxes which may be levied without limitation as to rate or amount upon all the taxable tangible property, real and personal, within the territorial limits of the City.
